## ***Terms & Conditions***

### **1. Booking Deposits / Security Deposits/ Payments / Cancellations**

Booking / security deposits:

A security deposit of \$450 will be applied to any rental to protect against loss, damage, or any other costs associated with the rental. A booking deposit of varying amounts will hold the booking and may be refundable depending upon the cancellation time.

When booking more than 1 week from service date: A deposit of \$200 is due upon receiving a signed copy of the Rental Agreement. The remaining total is due on the scheduled delivery date. A booking cancelled more than 7 days prior to scheduled delivery, will have booking deposit refunded in full. If a reservation is cancelled 7 days or less prior to scheduled delivery, the booking deposit is non-refundable.

When booking within 7 days of the service date: The security deposit of \$450 dollars is due upon receiving a signed copy of the Rental Agreement. A booking deposit for the total amount of the estimate is due for bookings that are a week or less. For bookings that are more than a week, half the total estimate is due. The booking deposit is non-refundable if cancelled with 48hrs of the service date. The security deposit is refundable.

When booking an emergency rental within 48hrs of service date: The security deposit of \$450 dollars is due upon receiving a signed copy of the Rental Agreement. A booking deposit for the total amount of the estimate is due for bookings that are a week or less. For bookings that are more than a week, half the total estimate is due. Booking Deposit is non-refundable. Security deposit is refundable.

Reducing rental length:

Rates quoted prior to service are based upon information given to Easy Chill Rentals by the renter at the time of booking and are agreed upon. If the rental length is decreased after the beginning of the service date then the following daily rates will apply and take precedent over the quoted amount. 1-3 days: \$200/day, 4-7 days: \$150/day, 8-21 days: \$125/day, 22+ days: \$100/ day. Any other rates used are at the discretion of the owner (Easy Chill Rentals Ltd.).

Increasing rental length:

The renter may request an extension to the rental length, however the owner (Easy Chill Rentals) reserves the right end non-scheduled extensions to rental agreements in order to fulfill previous bookings, service, or for any reason after the original booking is complete. If an extension is agreed upon then the following rates will apply: Extending a 1-3 day rental \$200/ day, extending a 4-7 day rental: \$150/day, extending an 8-21 day rental: \$125/day, extending a 22+ day rental \$100/day. Any other rates used are at the discretion of the owner (Easy Chill Rentals Ltd.).

\*Emergency / Rush delivery rates may apply at discretion of owner.

\*\*\*Renter shall pay all charges incurred in connection with the rental.

## **2. Loss or Damage to Trailer**

The Owner (Easy Chill Rentals) reserves the right to charge a security deposit of \$450.00. The owner reserves the right to charge renter for all loss, damage and/or mechanical repairs to Trailer and/or accessories, regardless of fault, resulting from abuse and/or misuse and/or negligence. All damage incurred during rental of the trailer can be subtracted from the security deposit. Any damages over and above the amount of the amount of the security deposit will be billed to the renter.

All keys received by the Renter shall be returned when the trailer is picked up. In the event that any keys / locks are not returned or there are any missing keys, the Owner (Easy Chill Rentals) reserves the right to charge the renter a replacement fee of \$100.00. Stairs to enter the trailer will be provided, and the owner reserves the right to charge \$200.00 for replacement due to damage or loss. If shelving provided is damaged, the owner reserves the right to charge \$75.00 per shelf for replacement due to damage or loss. Heavy duty extension cords will be provided and must be used. The owner reserves the right to charge \$75.00 per cord for replacement due to damage or loss.

## **3. Renters Liability**

If any claim is made against the Owner by a third party, arising out of the use of the Trailer, however such claim is framed by the third party, the Renter will indemnify the Owner, in full, for any such claim. Neither the Owner, nor the Manufacturer will be liable, in any event, for consequential damages arising from the use or failure or mechanical or other break down of the Trailer.

## **4. Loss of Use**

Renter agrees to pay a sum equal to the regular daily rental rate of the Trailer for each day the Trailer is unavailable for rent, regardless of fault, while any damage and/or mechanical repairs are made.

## **5. Trailer Delivery & Pick Up**

The Renter agrees to accept responsibility for electrical power supply to Trailer junction box, (connection and disconnection), and any necessary licenses, permits and inspections that may be required by local governing bodies. Failure to ensure that there is adequate power available, which results in lost time for the Owner will be billable at \$60/hr. The Renter (or representative on site) will sign off on the condition of the Trailer upon delivery and upon pick up of the Trailer. The Renter will ensure that the Trailer will be free of product and ready for pick up by the Owner as scheduled. It is the Renter's responsibility to ensure all locks, keys, electrical cords, steps, shelving and any other accessories provided with the unit are available upon pick up. If an extension on the rental period is required, it is the Renter's responsibility to provide the Owner with a minimum of 24 hrs. notice to request an extension.

## **6. Trailer Placement**

The Renter agrees that the area where the trailer is to be placed is to be free of obstruction and accessible at time of scheduled delivery and pick up. Any delays incurred as a result of site not ready, inaccessibly, excessive waiting time, or requests to return to delivery location to relocate the trailer will result in additional fees. (\$60/hr)

## **7. Cleaning**

Renter will accept responsibility of having the Trailer unit tidy and ready for pickup at the scheduled time. Renter agrees to leave the unit interior clean using minimal water. Power washing of the unit is prohibited. During the rental period, evidence of normal usage is expected, however if the Trailer has

sustained unusual levels of “mess”, cleaning charges may be applicable at \$50.00/hr, at the discretion of the Owner and will be charged to the security deposit or same credit card number provided for this rental term.

**8. Delays and Possible Breakdowns**

Neither the Owner (Easy Chill Rentals Ltd.) nor the Manufacturer will assume responsibility for loss of time, wages, inconvenience, loss of product, or other consequential damage or experience as a result of any issue with operation of any item rented from the owner (Easy Chill Rentals Ltd.) It is recommended that the Renter regularly monitor the unit to ensure it is operating at the desired temperature.

**9. Prohibited Use**

The Trailer of this contract shall not be used:

By any party not specifically named in this agreement, For anything other than the purposes provided, In any contest, In violation of any law.

**10. Repossession**

The Owner reserves the right to terminate this agreement and repossess the Trailer at any time.

**11. Initials:**
